2. Skate 75% of their time on Boise Figure Skating Club home ice (Idaho Ice World, 7072 S. Eisenmann Rd., Boise, ID 83716).

Waiver, Release and Disclaimer of Liability and Indemnification Agreement

I, the undersigned, acknowledge and agree that I or my minor child use the Idaho Ice World at my or my minor child's sole risk and that the City of Boise, and its servants, agents, employees and officials, including the directors of the Boise Figure Skating Club, shall not be liable to me for any claims, demands, injuries, damages, actions, or causes of action whatsoever, to my minor child, my person, or property arising out of or in connection with my or minor child's use or presence at Idaho Ice World and/or any services or programs offered at Idaho Ice World, whether offered by the City of Boise, the Boise Figure Skating Club, or by a third party.

Further, I do expressly hereby forever waive, release and discharge the City of Boise, and its servants, agents, employees, and officials, including the directors of the Boise Figure Skating Club, from all claims, demands, liabilities, injuries, damages, actions, or courses of action by me and from all acts of active or possible negligence on the part of the City of Boise, and/or its servants, agents or employees, including the directors of the Boise Figure Skating Club, against me or my minor child, arising out of or in connection with my or my minor child's use of or presence at Idaho Ice World or participation in any services or programs offered at Idaho Ice World, whether offered by the City of Boise, the Boise Figure Skating Club, or by a third party.

I further agree that I will indemnify and hold the City of Boise, and its servants, agents, employees and officials, including the directors of the Boise Figure Skating Club, harmless from and against any and all claims demands, liabilities, injuries, damages, loss, expense, actions, or property damage or personal injury sustained by myself, my minor child, or third person as a consequence of

the negligence or willful misconduct in the use of or presence at Idaho Ice World and/or participation in any services or programs offered at Idaho Ice World by myself or my minor child.

Consent for Participation

I agree, or hereby grant permission for my child, to participate in the activities of the Boise Figure Skating Club and certify that I am, or my child is, physically capable of participating in such activities. I understand that the Boise Figure Skating Club, its officers, members, professionals, coaches and agents assume no responsibility for injuries incurred during such participation in club activities. As in any athletic program, I realize that the possibility of injury exists. I understand that reasonable precautions will be made to prevent injuries from happening.

I understand that my, or my child's, picture may be used in club publications, advertisements and promotion, in print, or on the club website. I further understand that it is my responsibility to notify the club in writing if I want to revoke or restrict my permission to use my, or my child's, photograph.

Authorization for Medical Treatment

I authorize the Boise Figure Skating Club through its professionals and supervising officers or agents to secure medical care and treatment for me or my child which may be medically necessary in the event of illness or injury during participation in club activities.

Release Liability

I recognize that the Idaho Ice World rink staff or the Boise Figure Skating Club officers, board members, professionals, coaches or agents are not responsible for me or my child before, after, or during club activities. I assume responsibility for picking up my child immediately after any club activity. In recognition of the fact that I or my child may be injured during club activities, I expressly assume the risk of such injury. I release and discharge the Boise Figure Skating Club, its officers, members, professionals, coaches and agents from any and all claims and damages for personal injury and/or property damage which may arise from or out of my or my child's participation in club activities including, but not limited to, instruction, use of ice, and participation in ice shows, both on or off the ice.

Consent to abide by Rules and Regulations

I, on my and my minor child's behalf, hereby agree to abide by the bylaws of the Boise Figure Skating Club and to observe the Code of Conduct, rules, and policies of the Boise Figure Skating Club, and to observe ice etiquette and courtesy at all times. I also agree to observe all rules, policies, and procedures of U.S. Figure Skating and any rules of Idaho Ice World during any club activity. I understand that failure to abide by these rules may result in loss of my or my child's membership with the Boise Figure Skating Club.

I recognize that my or my minor child's participation in all general skating sessions, classes, competitions, exhibitions, and training camps hosted, supported, or sponsored by the Boise Figure Skating Club is an honor and privilege that carries certain responsibilities. On my and my minor child's behalf, I agree to fully abide by the rules and guidelines set forth by the Boise Figure Skating Club and U.S. Figure Skating. As a precondition to participation in events hosted, sponsored or supported by the Boise Figure Skating Club, I will act in harmony with philosophy and principles of the Boise Figure Skating Club. I will reflect the Boise Figure Skating Club's high standards in conduct, speech and appearance – whether on the Idaho Ice World premises or at any Boise Figure Skating Club functions – to other skaters, coaches, staff, parents, and the public. I (or a responsible adult) will accompany my child to all club-related events. I agree to conduct myself as a prudent, responsible, and ethical member of the community. This means I agree to act in good faith, to exhibit honesty, integrity and exemplary conduct, and to observe all Boise Figure Skating Club rules and regulations, as may be modified from time to time.

- Immoral or indecent conduct
- Willful damage or destruction of facility equipment or property
- Possession, consumption, or being under the influence of alcohol or tobacco by a minor
